Special considerations

- Use the LC cutter table to cutter the title right after the number. In the "b" use the first 3 letters of the author's surname.

- Because the **K General Law** classification only allow 2 numbers to allocate the European Union countries law, i.e from K3824 to K3826, we may extend the classification in case that we need to add more related topics: for example:

- Add the year to the subfield "|b" if 2nd edition or higher.

- Always check library catalog to see if the given number already exists. If yes, use the cutter table expansion numbers to cutter the title. For example, for a book related to Administrative law, with the correspondent number K3825.2, and the author Rivero Ysern, José Luis, and the title Manual de Derecho Local, the final call number should be K3825.2 M3 Riv. This call number may already exists either because the same author has another book about administrative law with a similar title starting by "Manual..." or because there is another author with the same surname and with the same title; in this case we may add one more number using the LC Cutter table expansion numbers to cutter the title so that the call number will be K3825.2 M361 Riv.

- KJE materials should be corrected to K.
